# Survivor Spotlight – Joshua Harmon, Goodwater, AL

I dreamed of becoming an R.N. when I was growing up because I wanted to help people feel better. On December 7, 2016, while I was a student enrolled at Central Alabama Community College, I decided to go meet up with some classmates on a Wednesday night, instead of going to church as I had told my mother I would be attending. That night, at the age of 19, I was hit by a car while walking. Thankfully someone called 9-1-1. I was airlifted to UAB, where I was found to have sustained several life-threatening injuries, intracranial bleeding along with a subdural hematoma, internal bleeding, and numerus fracture. During the surgical repair of the bilateral tibia/fibular fracture, several blood clots dislodged. As a result, I had two left-sided cerebral vascular accidents. I lost my peripheral vision and the ability to speak, eat, walk, and perform all activities of daily living. My biggest struggle was learning to speak without repeating the same phrases over and over.

Rehabilitation began for me when I was transferred home with Kindred Home Health having a daily regimen of PT, OT, and ST. My biggest struggle was, and which is still frustrating at times, communicating verbally while using the accurate wording effectively. Toni, my home health PT assistant, made a difference because she was so kind and patient during our sessions. After seeking further rehabilitation in an inpatient therapy setting at Lakeshore Rehabilitation, I learned to walk better with a walker along with multitasking skills. Upon attending several camps hosted by AHIF, I learned different types of physical exercise which has aided in my recovery. The best act that made the difference in my survival was accepting Jesus Christ as my Lord and Savior after I went back to church post-accident. I am more determined now to see Jesus Christ and tell everyone about Him because I was given a second chance. At the end of the day, it does not matter what mistakes you make in life. Always remember that if there is breath in your body, you can overcome every challenge by praying, working hard, and never giving up. My goal is to jog, run, and one day complete my nursing degree.

#### **TBI Grant Updates**

State Head Injury Coordinator, April Turner, Project Coordinator, David White and Project Evaluator, Dr. Despina Stavrinos, met with the Commissioner of the AL Department of Mental Health (ADMH), Kimberly Boswell and the ADMH/ADRS TBI Leadership Team this quarter to debut the Online Brain Injury Screening Services Support Tool (OBISSS) to all Leadership and to begin coordinating and implementing across all ADMH Programs. The TBI Federal Grant Team also presented to Hospital Behavioral Health/Psych Unit Directors at the Alabama Hospital Association's quarterly meeting. Discussion on possible implementation of the OBISSS into each hospital's electronic health records began.



The **Registry Helpline** had a total of 50 referrals and/or phone calls through the 1st quarter of FY23.

The Alabama Head and Spinal Cord Injury Registry (AHSCIR) requires hospital trauma TBI records be collected, reviewed, and eligible individuals contacted for needed linkage to crucial services and supports statewide. For the 1st quarter of FY23, 1,297 new records were received from Alabama Dept. of Public Health and 701 individuals were eligible to be contacted to provide information and referral assistance from ADRS, AHIF, and other community agencies.
