Augmentative Communication Technology (ACT) Clinic

An opportunity for individuals of any age with a variety of disabilities to enhance their communication with assistive devices.



ACT Clinic Services

- Multidisciplinary team evaluation, including specific recommendations, methods of access for a communication device, type and size of communication symbols, fine and gross motor assessment, and proper seating and positioning
- Trial use of devices
- Funding information and guidance
- Consultation and technical assistance for schools and employers
- Orientation and training for clients and caregivers
- Training for school personnel and private clinicians
- Referral for outpatient speech or other services
- Re-evaluation

- Speech-language pathologist
- Physical therapist
- Occupational therapist
- Rehabilitation technology specialist
- Social worker



To receive services through the ACT Clinic, an individual must have an eligible CRS medical diagnosis that directly impacts communication ability. For more information about ACT Clinic, contact the CRS office in your area.
